
**STIPULATIONS**

1. Test prep courses may be offered online or in an online / in-person modality
2. Both course tuition and mandatory fees may be certified to VA
3. Prep Course is approved for reimbursement of cost only
4. There is no monetary cap for the courses, as the cost are charged to educational entitlement
5. For educational assistance to be payable for a license or certification, the test must already be approved under Code of Federal Regulation 21.4268(b)
6. Beneficiaries may repeat the course as many times they deem appropriate

7. Prep courses can only be reimbursed to those who are both eligible and have remaining entitlement to VA educational assistance

This approval is not final until the U.S. Department of Veterans Affairs accepts the recommendation. At that time, you will receive an updated VA Form 22-1998 (WEAMS report) from VA. Upon receipt, please read it carefully to ensure accuracy.

The facility must notify and submit any changes or revisions to the documentation and information provided to the Florida SAA, within 30 days. Changes include, but are not limited to: ownership, chief administrative officers, location, licensure, profit status, new catalog, and cost of prep course. Failure to submit timely notification and/or deviation from information submitted to the Florida SAA, which served as a basis for this approval, may result in suspension or withdrawal of the institution's approval to participate in VA Educational Assistance
